



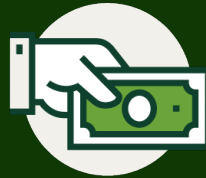

# Donor Advised Fund?



A donor advised fund (DAF) is a charitable investment account designed exclusively to support the charitable organizations you care about.

Imagine having a smart and flexible way to support the causes you care about most.

A DAF enables you to:

- + Make a charitable contribution and receive an immediate tax deduction.
- + Recommend grants from your fund to your favorite organizations on your timeline.
- + Contribute frequently or occasionally.

### 1. Open Your Donor Advised Fund

Start by naming your fund and appointing your advisors and successor advisors. It's simple to get started!

### 2. Fund Your Donor Advised Fund

Make an impactful contribution of at least \$50,000\* in cash, securities, or other property (following TSF's Gift Acceptance Policy). Enjoy an immediate tax deduction, subject to tax law limitations.

### 3. Make Additional Contributions

Add to your fund whenever you're ready. Contributions are generally tax-deductible in the year they're made.

### 4. Recommend Grants to Charities

Use our easy Grant Recommendation form to request grants as small as \$50\*.

Support qualifying 501(c)(3) public charities that align with the values of the Restoration Movement Christian Churches and Churches of Christ.

### 5. Enjoy Simplified Recordkeeping and Administration

Keep all your charitable giving organized in one place. We handle the paperwork so you can focus on supporting the causes you care about.
